

Successful Co-Parenting Program for Divorcing Parents

Parents are forever:

Divorce is a very stressful experience for parents and children. Although spouses may decide to end their marriage, their children will always need both their parents to be part of their life. This 2½ hour educational program will focus on what children need during and after the divorce and how parents can help them succeed. It is conducted by qualified professionals from OSU Extension and the Delaware Community.

Who must attend:

By local rule of the Delaware County Court of Common Pleas, Domestic Relations Division, all parents with minor children who are parties to a divorce, dissolution, or legal separation action must attend. Other concerned people (grandparents, attorneys, friends, counselors, etc.) may attend voluntarily, but approval for guests to attend must be obtained at the time of pre-registration.

Pre-registration:

Pre-registration is required. Parents who have not pre-registered will not be admitted. Call OSU Extension office at 740-833-2030 for seminar dates and to pre-register. Please give your court case number when you pre-register. You and your child's other parent will each need to pre-register separately and may attend separate sessions if requested.

A certificate of attendance will be given to participants who complete the entire session and have paid program fee. The program will notify the court of your attendance.

NOTE: Please arrive or log in 10 minutes before your scheduled session to sign in for attendance.

Time:

The program will be offered the first Wednesday evening of each month (exception if date falls on a holiday) beginning at 6:00 p.m. and ending at 8:30 p.m.

Location or Virtual:

The program is being held Virtual by a Zoom Meeting. It may change to in person and be held at the Byxbe Campus Offices, 1610 St. Rt. 521, Delaware, Ohio.

Please refer to your confirmation email from the OSU Extension Office for the program details.

Fee:

A \$30.00 fee per participant is payable to OSU Extension. Check/cash can be paid at the OSU Extension office or paid by a credit card link sent in the confirmation email once you have called to pre-register.
